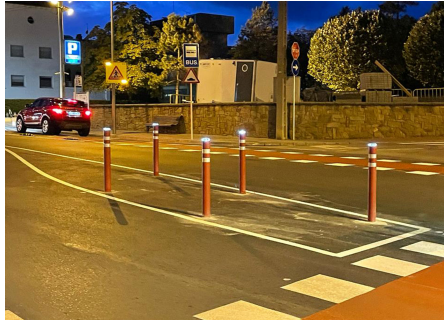

Recycled PVC Drop separators, Mai bollards, and universal bicycle racks have been installed on both streets.

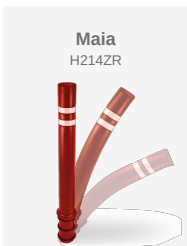
